

Based on Article 6, Paragraph 10 of the Law on Games of Chance ("Official Gazette of the RS" No. 18/20),

the Minister of Health brings

RULES

of the appearance and content of the poster with the notice, i.e., the appearance and content of the warning about the prohibition of the participation of minors in games of chance with the relevant text of the warning about the prevention of addiction

"Official Gazette of the RS" No. 13 dated February 4, 2022, 134 dated December 2, 2022.

Article 1

These Rules shall regulate the appearance and content of the poster with the relevant text on the prevention of addiction with contact information of the institution certified by the Ministry of Health for the treatment of addiction to games of chance (the institution) and a notice, that is, a warning about the ban on the participation of minors in games of chance, with the relevant warning text about the prevention of addiction.

Article 2

The organizer displays a poster near the entrance door inside the building where the games of chance are organized. The poster is 100 x 80 cm in size, containing the relevant text about the prevention of addiction, and the institution's contact information.

A legal entity and an entrepreneur based in the territory of the Republic of Serbia, receiving payments for the organizer of special games of chance through electronic means of communication, prominently displays the poster from paragraph 1 of this Article.

Article 3

The poster from Article 1 of these Rules has a format of 100 x 80 cm, with text on the prevention of addiction, contact information, and the logo of the institution (name, address, phone number) and the Ministry of Health.

The background of the poster is white.

The notice, that is, the warning about the prohibition of the participation of minors in games of chance, has the form of a rounded red rectangle of 47 x 74 cm, in the middle of which there is a circle with a diameter of 32 cm with an oblique line crossing the number 18.

Number 18 represents the number of years when a person acquires the right to decide on their rights and obligations independently. The poster is white, 16.4 cm high, and 18.8 cm wide. The oblique line is laid at an angle of 45 degrees against the horizontal diameter of the circle. The inside of the circle is red, and the outside and diagonal lines are white, 2 cm thick.

The text below the prohibition sign is written in white, font size of 2.2 cm.

The following text is written below the rectangle from paragraph 2 of this Article: "MINORS ARE PROHIBITED FROM PARTICIPATING IN GAMES OF CHANCE".

Below the red rectangle with a distance of 1.2 cm, there is an orange rectangle with rounded edges measuring 20 x 74 cm, containing a drawing (head, hash sign, card, dice) and a warning text about addictive diseases written in 1.3 cm white letters:

"Games of chance are intended for the entertainment of adults only. Participating in games of chance can distance a person from family, friends, and normal activities related to their age. Participating in games of chance can cause an addiction that requires treatment!"

Below the orange rectangle, there is a navy blue rectangle with rounded edges measuring 13 x 74 cm, with contact information of the health care institution, and a drawing (illustration) of the institution in white letters of 1.3 cm size. The place intended for the logo of the institution and the Ministry of Health is marked with blue and white letters in a gray rectangle below the navy blue rectangle with rounded edges, measuring 13 x 74 cm.

The poster from Article 1 of these Rules is printed with these Rules and is an integral part hereof.

The poster of prescribed appearance and content, graphically prepared for printing in .pdf format, is available on the website of the Administration for Games of Chance and the Ministry of Health.

The persons from Article 2 of these Rules print the poster with digital printing using the CMYK color system.

Article 4

These Rules shall enter into force on the eighth day after the date of its publication in the "Official Gazette of the Republic of Serbia".
