REGULATION

ON THE CONDITIONS FOR PERFORMING THE REPAIR OF TABLES FOR GAMES OF CHANCE, AUTOMATIC EQUIPMENT AND BETTING EQUIPMENT AND THE METHOD AND PROCEDURE FOR DETERMINING THEIR TECHNICAL VALIDITY

"Official Gazette of the Republic of Serbia, No. 78 dated 12 September 2025.

Article 1.

This Regulation prescribes in more detail the conditions for legal entities that may obtain authorization to repair tables for games of chance (hereinafter: tables), automatic equipment for games of chance (hereinafter: automatic equipment) and betting equipment, as well as the method and procedure for determining their technical validity.

Article 2.

The repair of tables, automatic equipment and betting equipment, within the meaning of this Regulation may be carried out exclusively by legal entities authorized by the Minister of Finance that do not organize games of chance (hereinafter: authorized repair person).

Article 3.

The following documentation shall be attached to the application for authorization to repair tables, automatic equipment and betting equipment, which shall be submitted to the Ministry of Finance through the Games of Chance Administration (hereinafter referred to as the Administration):

- 1) decision on entry into the appropriate register with the registered activity Technical Testing and Analysis 7120;
- 2) proof of ownership, right of use or lease of the business premises where the repair of tables, automatic equipment and betting equipment is carried out;
- 3) proof confirming that at least three persons with a higher education in electrical engineering are employed, of whom at least one person is employed for an indefinite period by the applicant;
- 4) proof of possession of equipment for the repair of tables, automatic equipment and betting equipment at the applicant's disposal;
- 5) proof of the amount of the applicant's share capital, which cannot be less than the dinar equivalent of 20,000 euros calculated at the official middle exchange rate of the National Bank of Serbia, provided that the value of the registered and paid-in founder's share capital cannot be lower than the stated amount;
- 6) statements by employees committing to keeping confidential business data obtained through their activities, certified by the applicant.

The Administration shall ex officio obtain data from official records, unless the applicant expressly states that it will obtain such data itself.

Article 4.

Table repairs by an authorized repair person, for the purposes of this Regulation, are considered to be repairs to damage to the table or replacements of table parts that may affect the regularity of the game described in the rules of the game to which consent has been given by the Administration.

Repair of automatic equipment or betting equipment, which, in accordance with the regulation governing the technical and functional characteristics and the method and procedure for testing the fulfillment of the necessary conditions, is considered to be automatic equipment on which players are allowed to play betting games on a computer-generated virtual event, by an authorized repair person, within the meaning of this Regulation, includes any repair that requires removing seals, changing the value of the dial, restoring the memory to the factory state resetting (ram clear) or other modification of the software or hardware component of the automatic equipment or betting equipment that may affect the game on the automatic equipment or betting equipment on which players are allowed to play betting games on a computer-generated virtual event, except for adding or removing a betting game on a computer-generated virtual event on the betting equipment.

After the repair, the authorized repair person is obliged to place a new seal, draw up a report and issue a certificate of completed repair of the tables, automatic equipment or betting equipment on the PIP form - Certificate of Completed Repair, which is printed with this Regulation and forms an integral part thereof, which must contain the following information:

- 1) numerical number of the label;
- 2) manufacturer (of the table, automatic equipment or betting equipment);
- 3) category (of the table, automatic equipment or betting equipment);
- 4) type (of the table, automatic equipment or betting equipment);
- 5) month and year of manufacture (of the table, automatic equipment or betting equipment);
- 6) unique serial number of the table, automatic equipment or betting equipment;
- 7) proof of ownership of the table, automatic equipment or betting equipment;
- 8) information about the organizer;
- 9) information on the address of the facility where the table, automatic equipment or betting equipment is located;
 - 10) information on the authorized repair person;
 - 11) reason for performing the repair;
 - 12) date of receipt of the repair request and preparation of the record;
 - 13) specification of the work performed;
- 14) condition of the dial (only for automatic equipment and betting equipment that are considered to be automatic equipment in accordance with the regulation governing the technical and functional characteristics and the method and procedure for testing the fulfillment of the necessary conditions);
- 15) condition of the seals (with the removed and new program seal and with the removed and new seal on the connector (only for automatic equipment and betting equipment));
 - 16) signature of the responsible person in the authorized repair person;
 - 17) signature of the responsible person of the organizer;
 - 18) place and date of issue of the certificate of repair.

The authorized repair person is obliged to submit a certificate and a report on the completed repair of the table, automatic equipment or betting equipment to the laboratory authorized by the Minister of Finance (hereinafter: the laboratory) within 24 hours from the date of drawing up the report.

If the repair has resulted in a change in technical and functional characteristics, the authorized repair person is obliged to specifically emphasize this in the certificate and the report on the repair.

The laboratory is obliged to issue the organizer, after checking the report and the submitted documentation on the repair, a supplementary certificate on the technical and functional characteristics of the tables, automatic equipment or betting equipment, no later than the end of the next working day and submit it to the Administration within the same period.

The certificate referred to in paragraph 6 of this Article shall state the information on the reason for removing or changing the seal.

The laboratory may subsequently check whether the repair was carried out in accordance with the report and documentation on the repair.

At the request of the Administration, the laboratory is obliged to carry out a subsequent check referred to in paragraph 8 of this Article.

The authorized repair person keeps records of all repairs through a service book individually for each table, automatic equipment or betting equipment, which can also be in electronic form.

Article 5.

Tables in use must be technically valid.

Determining the technical validity of a table, within the meaning of this Regulation, involves the procedure of checking:

- 1) whether the label for marking and registering the table, including its content, is in accordance with the Law on Games of Chance ("Official Gazette of the Republic of Serbia", No. 18/20 and 94/24 hereinafter: the Law):
- 2) whether the technical and functional validity of the table is in accordance with the certificate of compliance with the technical and functional characteristics of the table issued by the laboratory;
- 3) whether only those games of chance described in the rules of the game of the organizer, approved by the Administration, can be played on the tables.

The organizer is obliged to submit to the Administration, within five days from the date of determination of the technical validity of the table by the authorized repair person, a Certificate of Technical Validity, which is printed with this Regulation and forms an integral part thereof.

The technical validity of the table is checked every year, within ten days from the date of expiry of one year from the previous check of the technical validity of the table by the authorized repair person, with the technical validity of the table being determined for the first time by the laboratory, in the procedure of testing the fulfillment of the technical and functional characteristics of the table.

At the request of the competent authority, i.e. the organizer, the authorized repair person performs an extraordinary procedure of determining the technical validity of the table.

Article 6.

Automatic equipment and betting equipment in use must be technically valid.

Determining the technical validity of an automatic equipment and betting equipment, within the meaning of this Regulation, involves the procedure of checking:

1) whether the label for marking and registering the automatic equipment and betting equipment, including its content, is in accordance with the Law;

- 2) whether the technical and functional validity of the automatic equipment and betting equipment is in accordance with the certificate of compliance with the technical and functional characteristics of the automatic equipment and betting equipment issued by the laboratory;
- 3) whether only those games of chance for which an authorized laboratory has issued a certificate and which are described in the rules of the game of the organizer, to which the Administration has given consent, can be played on the automatic equipment or betting equipment;
 - 4) dial condition;
 - 5) seal condition.

The organizer is obliged to submit to the Administration, within five days from the date of determination of the technical validity of the automatic equipment and betting equipment by the authorized repair person, a Certificate of Technical Validity on the PTI form.

The technical validity of automatic equipment and betting equipment is checked every year, within ten days from the date of expiry of one year from the previous check of the technical validity of the automatic equipment or betting equipment by the authorized repair person, provided that the technical validity of the automatic equipment and betting equipment is first determined by the laboratory, in the procedure of testing the fulfillment of the technical and functional characteristics of the automatic equipment and betting equipment.

At the request of the competent authority, i.e. the organizer, the authorized repair person performs an extraordinary procedure of determining the technical validity of the automatic equipment and betting equipment.

Article 7.

The authorized repair person is obliged to:

- 1) act in accordance with the regulations governing the field of games of chance;
- 2) professionally and conscientiously perform the tasks specified in this Regulation;
- 3) cooperate with the Administration and the laboratory;
- 4) be responsible for the work performed;
- 5) keep confidential the business data obtained through the performance of the activity in accordance with the regulations governing the protection of business secrets and the protection of personal data.

The provision of data to a competent authority, or laboratory, for the purposes of implementing regulations governing the field of games of chance shall not be considered a breach of the obligation to maintain business secrets referred to in paragraph 1, item 5) of this Article.

The authorized repair person is obliged to publish an updated price list on its official website.

Article 8.

The costs of repairs and determining the technical validity of tables, automatic equipment and betting equipment shall be borne by the organizer.

The Administration shall supervise the work of the authorized repair person.

The Administration shall keep records of all legal entities authorized to repair tables, automatic equipment and betting equipment.

The Minister of Finance may revoke the authorization of a legal entity authorized to repair tables, automatic equipment and betting equipment if it ceases to meet the conditions for

performing these tasks prescribed by the Law and this Regulation, as well as upon the proposal of the Administration in the event that it fails to meet the obligations prescribed by Article 7 of this Regulation.

Article 9.

Legal entities that have received the authorization of the Minister of Finance for the repair of tables and automatic equipment until the date of entry into force of this Regulation shall continue to operate, that is, to perform tasks based on the given authorization in the manner and according to the procedure prescribed by the provisions of the Law and this Regulation.

The issued authorization referred to in paragraph 1 of this Article shall also apply to a betting equipment that has the characteristics of an automatic equipment.

Article 10.

On the date of entry into force of this Regulation, the Regulation on the Conditions for Performing the Repair of Tables and Automatic Equipment for Games of Chance ("Official Gazette of the Republic of Serbia", No. 152/20 and 22/21) shall cease to be valid.

Article 11.

This Regulation shall enter into force on the eighth day after its publication in the "Official Gazette of the Republic of Serbia".
