

In accordance with Article 76, paragraph 6 of the Law on Games of Chance (“Official Gazette of the Republic of Serbia”, No. 18/20),

the minister of finance issues the following

**REGULATION
ON THE MANNER OF KEEPING MANDATORY RECORDS AND REPORTING ON
ACHIEVED TURNOVER ON AUTOMATIC EQUIPMENT¹**

(Official Gazette of the Republic of Serbia, No. 152/20)

The basic text comes into force from 26/12/2020, the application of this regulation comes into force from 11/07/2021.

Article 1

This regulation prescribes the manner of keeping mandatory records and reporting on the realised turnover on the automatic equipment of an organiser of special games of chance on automatic equipment (hereinafter: the “organiser”).

Article 2

The organiser is obliged to keep records of the monthly turnover per piece of automatic equipment, on the basis of which they determine the amount of the fee for organising special games of chance on automatic equipment.

Article 3

(1) The organiser submits data on the realised turnover per piece of automatic equipment to the Games of Chance Administration (hereinafter: the “Administration”) on an SCT form – sum of calculated turnover on automatic equipment – which is printed together with this regulation and forms an integral part thereof.

(2) The organiser shall submit the completed SCT form to the Administration by the fifth day of the month for the previous month electronically by connecting to the web service of the Administration.

(3) The form referred to in paragraph 1 of this article must contain the following information:

- 1) ordinal number;
- 2) unique serial number of the automatic equipment;
- 3) the amount of payments received per piece of automatic equipment by the players;
- 4) the amount of payments made to the players;
- 5) the amount spent in the game;
- 6) the amount won in the game;
- 7) the amount of the monthly fee for organising special games of chance on automatic equipment;

¹ Automatic equipment is considered electromechanical, electronic and similar devices that work based on an algorithm of random events, on which special games of chance are organised.

- 8) the signature of the responsible person who prepared the calculation;
- 9) the signature of the responsible person of the organiser.

Article 4

The organiser is obliged to submit the completed SCT form from Article 3 of this regulation electronically to the e-mail address of the Administration until the establishment of the technical conditions for electronic connection to the web service of the Administration.

Article 5

On the day the application of this regulation begins, the regulation on the manner of keeping obligatory records of the realised turnover on automatic equipment (“Official Gazette of the Republic of Serbia”, No. 129/04, 16/11 and 44/18 - other law) shall cease to be valid.

Article 6

This regulation shall enter into force on the eighth day from the date of its publication in the “Official Gazette of the Republic of Serbia”, and shall apply from 11 July 2021.
