

In accordance with Article 45, paragraph 4; Article 74, paragraph 4; and Article 89, paragraph 4 of the Law on Games of Chance (“Official Gazette of the Republic of Serbia”, No. 18/20),

the minister of finance issues the following

REGULATION
ON THE FORM AND CONTENT OF THE LABELS FOR THE IDENTIFICATION AND
REGISTRATION OF GAMING TABLES, AUTOMATIC EQUIPMENT¹ AND PAY-IN-PAY-
OUT DESKS IN BETTING SHOPS

(Official Gazette of the Republic of Serbia, No. 152/20)

The basic text comes into force from 26/12/2020, the application of this regulation comes into force from 11/07/2021.

Article 1

This regulation prescribes in more detail the form and content of the labels for the identification and registration of gaming tables, automatic equipment and pay-in-pay-out desks in betting shops.

Article 2

(1) The labels for the identification and registration of a gaming table must be displayed on the table and must include the following:

- 1) the numerical number of the label;
- 2) the name of the organiser of games of chance;
- 3) the name of the laboratory authorised by the minister of finance;
- 4) the unique serial number of the table;
- 5) the location and address of the casino;
- 6) the licence validity period.

(2) The labels for the identification and registration of automatic equipment must be visibly displayed on the automatic equipment and must include the following:

- 1) the numerical number of the label;
- 2) the name of the organiser of games of chance;
- 3) the name of the laboratory authorised by the minister of finance;
- 4) the unique serial number of the automatic equipment;
- 5) the location and address of the facility where the automatic equipment is located;
- 6) the licence validity period.

¹ Automatic equipment is considered electromechanical, electronic and similar devices that work based on an algorithm of random events, on which special games of chance are organised.

(3) The label for the identification and registration of a pay-in-pay-out desk in a betting shop must be visibly displayed on the pay-in-pay-out desk and must include the following:

- 1) the numerical number of the label;
- 2) the name of the organiser of games of chance;
- 3) the name of the laboratory authorised by the minister of finance;
- 4) the location and address of the pay-in-pay-out desk;
- 5) the licence validity period.

Article 3

(1) The labels for the identification and registration of gaming tables, automatic equipment and pay-in-pay-out desks in betting shops are made of white, self-destructive PVC material with an applied hologram 6 mm wide.

(2) The labels are self-adhesive, and are 80 mm x 60 mm in size.

Article 4

(1) The label is made and placed on the device by a laboratory authorised by the minister of finance after the completion of the procedure for checking the fulfilment of the technical and functional characteristics, as well as after the relocation of automatic equipment to another location.

(2) The device referred to in paragraph 1 of this article can be either a table for games of chance, automatic equipment or a pay-in-pay-out desk.

(3) The label is valid until the expiration of the validity of the licence, i.e. the approval.

(4) The replacement of the label or its removal is in the exclusive competence of the laboratory.

(5) The costs of obtaining the label shall be borne by the organiser.

(6) The request for the issuing of a label shall be submitted to the authorised laboratory on the label request form – label request for the identification and registration of devices – which is printed together with this regulation and forms an integral part thereof.

Article 5

On the day the application of this regulation begins, the regulation on the form and content of the special labels for casinos or betting shops, i.e. the place of payment in a betting shop (“Official Gazette of the Republic of Serbia”, No. 129/04) shall cease to be valid.

Article 6

This regulation shall enter into force on the eighth day from the date of its publication in the “Official Gazette of the Republic of Serbia”, and shall apply from 11 July 202.
